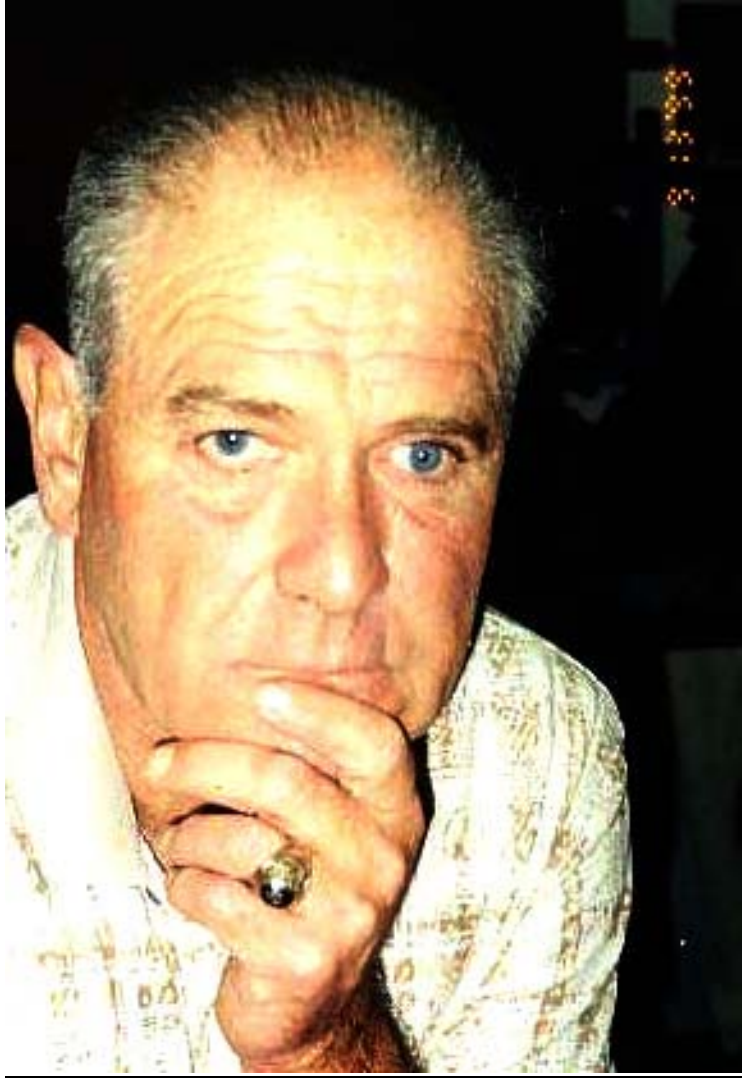

George Foster lost a very special friend this last month.**



George J Foster

Worked for the Illuminating Company and Electrical Code Expert.

He Joined the Illuminating Co. as a Cleveland District meter reader in July 1962 then worked his way to Consumer Services Dept's Customer Information Section as a customer information representative (55 Public Square Bldg.)

In 1970 George Transferred to the Marketing Dept., Sales Service Section (later

to become the Service Co-coordinating Section). During his tenure as a Technical Specialist Representative, his assignments included; administering the Area Light Program and Consumer Charge coordinator

In 1986, George was named the Company's National Electrical Code representative, during which time, he was appointed by the Company as it's representative to the Edison Electric Institute's National Electric Code matters.

This started his teaching of National Electrical Code classes. This encouraged George to join the International Association of Electrical Inspectors where as a leader he became President of the Western Reserve Division of the IAEI as well as President twice for the Ohio Chapter of the IAEI.

George served as Secretary / Treasurer for the Western Reserve Division up until last year when he stepped down due to his failing health. He served in this position for 27 years. George has been the Code "Goo-Roo" in Northern Ohio for the last 25 years. George sat on Code making panel 10 of the National Electrical Code for the 1996 edition. He taught Electrical Inspectors and Contractors on the National Electrical Code whether it was for re-certification or the first time student. He was always there for anyone who had a question.

In 1993, George retired from Centerior Energy (C.E.I. Co.) after a career spanning more than thirty years (30) of service to Community and Company. After retiring George accepted a position as Electrical Inspector for the City of Bedford Heights. He worked there until about two years ago. He enjoyed interacting with the public as well as with the Contractors. He touched so many peoples life's.
